- Master's Degree in "Medicine and Surgery" or other equivalent qualification class LM-41; EOF: 7.

Candidates in possession of an academic qualification obtained abroad, equivalent in duration and content to those listed above, can apply as well. In the latter case, candidates must provide Declaration of Value, issued by the Italian Consular Authority of the country of study (together with "Transcript of Records" + duplicate of final degree) or CIMEA Statements of Comparability along with CIMEA Statements of Verification (through CIMEA platform) or Diploma Supplement (in case of European Degrees) issued by the University of origin and legalized by the Italian Embassy of the country of study. Candidates who do not have or do not present by the first day of class the requirements laid down in the regulations in force, forfeit their enrolment if already admitted and have no right to refunds of any amount paid to the University. In case of lacking of the aforementioned requirements, Didactic Administrative Office can exclude candidates from the Master at any time and with a justified provision.

#### **VALUE OF THE MASTER TITLE**

Master Degree is a high level post-graduate scientific programme. The Master involve the acquisition of at least 60 university learning credits (ECTS). The second level Master's Degree represents from a classification point of view a course of study of the third cycle of the Bologna process / Level 8 EOF.

## Master Of Surgery in Implant Dentistry

The "University Master of Surgery in Implant Dentistry" (MS) is a specialized program designed to enhance the theoretical knowledge and practical clinical experience of general dentists in the field of implantology. It equips them with the skills and confidence to select patients, diagnose conditions, perform treatments, and carry out implant procedures. The program provides a thorough understanding of the biological aspects of implantology and offers clinical training through practical trials, enabling dentists to safely perform surgeries and maintain patients with dental implants.

The Master's program adopts a blended learning approach, combining theoretical webinars with hands-on classroom practice. It caters to the scheduling constraints and work responsibilities of participants who may find it difficult to attend in-person classes. Live lessons are provided to recreate the dynamics of a real classroom experience, and all lectures are recorded for later review and further study. The program consists of five Master sessions in total. Upon completion of the program, graduates will have the ability to independently develop and implement treatment plans for patients in need of dental implant prostheses. The course culminates with a Master's thesis focused on implantology topics, which students prepare throughout the year and present at the end of the course.

English serves as the official language of the Master's program. It is categorized as a "SCIENCE" program due to its technical and scientific orientation.

# TEACHING METHODOLOGY AND EDUCATIONAL PROGRAM

The modality of the Master is blended and it has a theoretical-practical approach aimed at providing a learning on the problems of the surgical and rehabilitation prosthetic phases supporting the implant.

The didactic calendar may be subject to change in relation to national and international scientific calendars and the availability of teaching staff. Upon activation of the Master (after the deadline for enrolment) the final schedule will be sent out. Any changes will be communicated by email.
